The Village of Highland Falls is an area that has great potential to be a great economic driver in the Mid-Hudson Valley and a vibrant community for families. Located on the doorstep of West Point, Highland Falls is uniquely positioned to be able to capitalize on the hundreds of thousands of visitors to West Point, Bear Mountain State Park, and Woodbury Commons every year. It is a special area that is ripe for investment to jump to a new level for Orange County, the Hudson Valley Region, and New York State.

A major driver of Highland Falls tourism, The United States Military Academy at West Point (USMA), is unique in that it attracts many families from around our Country and the World. Cadets and professors are specially selected from across the country to attend and teach at USMA in what has become a national treasure. Highland Falls can grow and increase by providing a beautiful hometown atmosphere to pull Military Families involved with USMA off of the military installation and into the town, where their money will be spent on local businesses and not on large national chains that are exempt from taxation by location on the federal Military Reservation of West Point. Currently, many families sequester themselves on West Point because there is not a pleasant atmosphere in town. An investment into Highland Falls would raise the bar and give these Military Families a reason to visit a beautiful destination rightly named "Hometown, U.S.A."

Due to its incredible location, Highland Falls can also provide a picturesque experience to two other very different types of visitors that frequent the area. The highly commercialized and very crowded Woodbury Common Premium Outlets draw one type of visitor, while Bear Mountain State Park draws a very different type of visitor. While visitors to either location would not necessarily visit the other on the same trip, they will overlap with interest in a pleasant, walkable, hometown experience. With Woodbury Common less than 14 miles away and Bear Mountain State Park only 4 miles, Highland Falls is well-placed to draw in visitors from both locations that can increase the value of the experience of all local destinations. It creates a synergy that is exceedingly rare.

Highland Falls is also beginning to draw additional local investment that a grant would shift into high gear. As a 2007 Graduate of West Point, I chose Highland Falls to open a small business instead of accepting an offer to work for a large corporation on Wall Street. I was able to take ownership and connect with real people in a way that I would not be able to working for a large firm. I am one of several West Point Graduates who sees the potential in the area and is willing to invest as we see the area beginning to turn a corner. As the area attracts more attention, a grant would help the area draw people who will be dedicated to improving and investing in their surroundings, not people who will try to squeeze everything out.

We see this grant as an investment into potential for future growth and improvement, not for need. Highland Falls should receive this grant not because it is an area that is in need, but because it will be a wisely spent investment that will enable the area to grow and give back to the rest of the County, Region, and State.

Thank you for inviting me to the Revitalizing Main Street Meeting. It was great to also see strong representation from the Military Academy and to have the opportunity to discuss mutual interests with those representatives. Being just across the River in Peekskill, we are appreciative of your efforts to improve one of the communities that we think of as our neighbors.

Camp Smith is New York State's only Army National Guard Training Site and provides a year-round training platform for New York Military Forces and a staging base from which those forces respond to civil emergencies. We have 200 personnel on site on any given day and up to 1,200 Soldiers on weekends and during summer training periods. We have limited capability to provide recreational opportunities to our tenants and Soldiers and rely on partnering with the Military Academy to fill this gap. In addition, there are multiple reasons for Soldiers to transit between Camp Smith and West Point to access services we cannot provide. As a result, our National Guard Soldiers travel through Highland Falls frequently.

Given all of these factors, it would be beneficial to have a revitalized Main Street in Highland Falls that would provide opportunities for our Soldiers to access dining and recreational opportunities in an attractive setting. We support your efforts to provide these opportunities.
